Subject: Debarment of Mr. Mohit Mohan Agrawal the engagement of NHIDCL/MoRT&H project for a period of 2 year.

It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRT&H that Mr. Mohit Mohan Agrawal was selected as Senior Quality cum Material Expert by M/s MARC Technocrats Private Limited for the work Consultancy Services for Authority's Engineer for Supervision of:

- Widening/Improvement to 4(Four) Lane with Paved Shoulder from Km 52.470 to Km 71.500 (Design Km 48.655 to Km 67.556) of Tulungia to Jogighopa Bridge Approach Section: Package-V of Bilasipara-Guwahati Road (NH-17) in the State of Assam under Bharatmala Paryojna on EPC Mode.
- Widening/Improvement to 4(Four) Lane with Paved Shoulder from Km 88.000 to Km 99.930 (Design Km 84.100 to Km 96.000) of Sagunbashi Forest (near Nichinta Bypass to the starting of Kirishnai Bypass Section): Package-VII of Bilasipara-Guwahati Road (NH-17) in the State of Assam under Bharatmala Paryojna on EPC Mode.
