DEBARMENT NOTICE

Subject: Debarment of **Mr. Niranjana Kumar Pathak** from engagement on NHIDCL/MORT&H projects for 2 years.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that **Mr. Niranjana Kumar Pathak** was appointed as “Senior Quality cum Material Expert” by M/s Technocrats Advisory Services Private Ltd. in association with M/s jagadambike Infrastolution Pvt. Ltd. for the work of Consultancy Service of Authority’s Engineers for supervision of “Construction of (i) 2 lane with hard shoulders of **Changtongya- Longleng road** on EPC basis from existing Km 0.000 to Km 16.592 (Design Chainage Km 0.000 to Km 18.779) (Design Length – 18.779 Km) (**Pkg – I**) (ii) 2 Lane with hard shoulders of Changtongya – Longleng road on EPC basis from existing Km 16.530 to Km 29.530 (Design Chainage Km 18.779 to Km 33.428)(Design Length – 14.649 Km) (**Pkg-II**) in the State of Nagaland under NH (O) Plan under SARDP – NE.

2. **Mr. Niranjana Kumar Pathak** has left the assignment in the middle of the work without any valid/justified reasons. He has provided his consent for his availability for the entire duration of the subject project. But he has not completed the assignment, thereby violating CA, TOR, Section-6, Cl. 11.2.

3. Therefore, as per stipulations of the CA, TOR, Section-6, Cl. 11.2, **Mr. Niranjana Kumar Pathak** is hereby debarred for 2 years from engagement on NHIDCL/MORT&H’s project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
