Ltd for the work of **Consultancy Services For Authority's Engineer For Supervision of: (i) Construction of Two lanning with Hard Shoulder Road of Ukhrul - Toloi - Tadbui section of NH-102A from Design Chainage 50.850 km to 81.870 km (Package-3) in the State of Manipur on EPC Mode; (ii) Construction of Two lanning with Hard Shoulder Road of Ukhrul - Toloi - Tadbui section of NH-102A from Design Chainage 81.870 km to 105.825 km (Package-4) in the State of Manipur on EPC Mode**
