Ltd for the work of Consultancy Services For Authority's Engineer For Supervision of: Improvement of existing road to 2 laning with Hard Shoulders of Maram-Peren section (Package-III, length 34.494 km) from Design Chainage km 75+000 to km 109+494 on NH-129A in the State of Manipur on EPC Mode.
