The Work of "Consultancy Services for Ayodhya 84 Kosi Parikrama Marg NH-227B" was awarded to M/s JC Technocrats Pvt. Ltd. vide C.B-08/SE Circle/2018-19, dated 03.10.2018.

M/s JC Technocrats Pvt. Ltd., New Delhi was debarred from all Consultancy Works of NH PWD for one year from all works of NH PWD/MoRTH/Centrally sponsored works of Ministry vide this office order letter no.296NH/ 21N/18, dated 24.01.2024, earlier due to the violation of the various sections of the Contract Agreement as it became imperative to take the penal action against the M/s JC Technocrats Pvt. Ltd. for "Non-Performance" & causing the time and cost overrun of the project and its adverse effect on the reputation of the Ministry and NH PWD.

M/s JC Technocrats gave representation for revoking the debarment order along with the project progress and subsequent project timeline for 84 Kosi Parikrama Marg Pkg-1, 2, 3, 4, 5 & 6 vide letter no. JCTPL/HD/UP275/39865 dt.29.08.2024 in the context of MoRT&H letter no. CE-RO/ LKO/In-Principle Approved NH/UP/2018-19/564/891, dated 16.08.2024.

Regarding this matter, the SE, NH Circle, PWD, Lucknow vide letter no. 2806/702C-NH Circle/2024, dated 29.08.2024 has recommended herewith to revoke the above debarment order.

Based on the recommendation of SE, NH Circle, PWD, Lucknow on the basis of present progress of DPR Consultant, the debarment of the DPR Consultant, M/s JC Technocrats Pvt. Ltd. vide Office Order no.296NH/21N/18, dated 24.01.2024 is hereby revoked and withdrawn with immediate effect.

It is pertinent to mention that, if the projects progress does not align with the submitted timeline by the DPR consultant then the action against the DPR consultant may be initiated as per the Para-9 of Ministry Circular No.- RW/NH-33044/24/2020-S&R (P&B), dated-06.01.2021.
