DEBARMENT NOTICE

Subject : Debarment of Mr. Rajeev Ranjan from engagement of NHIDCL/MoRTH projects for a period of 2 years.

It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that Mr. Rajeev Ranjan was selected as the Resident cum Highway Engineer by M/s Technocrats Advisory Services Pvt. Ltd. in Association with M/s. JR Consultancy Services Pvt. Ltd. (TASPL) for the work Consultancy Services as Authority's Engineer for Supervision of Up-gradation of NH-301 Kargil-Zanskar Road (pkg-4,5,6 &7) in the UT of Ladakh.

2. M/s TASPL vide letter no. 1503 dated 28.02.2022 has informed that Mr. Rajeev Ranjan, Resident cum Highway Engineer is not interested to join the site.

3. Therefore, as per clause 4.5.2 and 4.5.6 of Contract Agreement, Mr. Rajeev Ranjan is hereby debarred/blacklisted from participating in future projects of NHIDCL/MoRTH for a period of 02 years from the date of issue of this notice.
