

Debarment notice

Sub: Debarment of **M/s Chittaranjan Saha & Others** for a period of 06 months from participating in future projects to be undertaken by NHIDCL/MoRTH.

It is for general information to all concerned that **M/s Chittaranjan Saha & Others**, Agartala West Tripura 799001, Tripura is hereby debarred for a period of 06 months from the date of issue of this notice considering the representation submitted by **M/s Chittaranjan Saha & Others** vide letters dated : 15.12.2025 for failing in submission of performance security and additional performance security as per timelines mentioned in LOA in accordance with RFP clause no. 16.7 & clause no. 33.4 of section 2 of ITB for projects from Sl. (a) to (e) and in accordance with RFP clause no. 16.7, clause no. 16.6 (c) (ii) & clause no. 32.3 of section 2 of ITB for projects at sl.(f) as mentioned below :

- Maintenance & Repair work on Agartala to Khowai NH-108B Pkg-III from km 31.300 to km 45.300 at various sections i.e, Subalsingh to Khowai at the risk and cost of EPC Contractor in the state of Tripura in the FY 2025-26 on item rate basis & work order basis.
- One time improvement of Chandipur-Kanchanpur road of NH-44A from km 75.500 to km 86.000 in the state of Tripura in the FY 2025-26 on item rate basis & work order basis (Balance Work).
- Restoration & Repair work on NH-208 from km 49.200 to km 63.700 (Total Length - 14.500 Km) at various sections of Jurichhara to Bamanchara (Pkg-III) at the risk and cost of EPC Contractor in the state of Tripura in the FY 2025-26 on item rate basis & work order basis.
- Special Repair works on NH-208A from km 0.000 to km 11.800 (Total Length-11.800km) at various sections of Kailashahar to Kurti Bridge Pkg-I at risk and cost of EPC Contractor in the State of Tripura in the FY 2025-26 on item rate basis & work order basis.
- Restoration & Repair work on NH-208 from km 0.000 to km 18.600 (Total Length - 18.600 km) at various sections of Kumarghat to Kailashahar road at the risk and cost of EPC Contractor in the state of Tripura in the FY 2025-26 on item rate basis & work order basis.
- Special repair through Short Term Maintenance Contract on Mungiakami - Champaknagar road section in various stretches (from km 422.000 to km 423.000, km 436.700 to km 437.500, km 437.750 to km 438.000, km 438.340 to km 443.000, km 444.000 to km 445.000, km 453.000 to km 455.000 (Total Length = 9.710 km) & road safety work from km 422.000 to 456+500 (Length= 34.500 km) in the state of Tripura in the FY 2025-26 on percentage and work order basis.

2. The firm **M/s Chittaranjan Saha & Others** is debarred for a period of 06 months from participating in future projects to be undertaken by NHIDCL/MoRTH.
