## DEBARMENT NOTICE

## Subject: Debarment of Sh. Ajay Kumar Singh from engagement on NHIDCL/MoRTH projects for a period of minimum 02 years.

It is brought to notice of all Division/Units of NHIDCL and other agencies of MoRT&H that Mr. Ajay Kumar Singh was appointed as "Bridge/Structural Engineer" by M/s Aushta Consulting Engineers (I) Pvt. In JV with M/s DN Consultant for the work of Consultancy Services for Authority's Engineer for supervision of "Improvement/Widening to 2-lane with earthen shoulders of Ranikor-Maheshkhola-Baghmara road section (i) Package - IV from Kanai to Rongara, existing chainage from Km 85+970 to 102+345 (Design chainage from 81+100 to 96+000) design length - 14.763 Km and (ii) Package - V from Rongara to Panda, existing chainage from Km 102+345 to Km 119.810 (Design chainage from Km 96+000 to Km 112.300) design length - 16.300 Km on EPC Mode under SARDP - NE 'Phase A' in the State of Meghalaya" on 13.01.2021, which was the appointed date of the Authority Engineer.

2. Mr. Ajay Kumar Singh had taken a casual leave from 12<sup>th</sup> September to 20<sup>th</sup> September 2022, which he further extended till 10<sup>th</sup> October 2022. However, he resumed duties on 15<sup>th</sup> March 2023 after a lapse of 06 months without prior intimation and approval of the Authority, despite continuous instructions and notices from the Authority Engineer Team and concerned PMU. Furthermore, several complaints have been received that the said staff used to misbehave and create ruckus at site. Such incident had also occurred in a recent site inspection on 23.03.2023 where the Bridge Engineer tried to attack and manhandled the Authority representatives. Such type of illiterate and misconduct with any staff should be taken seriously and lawful action against the said staff may be taken to avoid such kind of unfortunate incidents in the future.

3. Therefore, as per stipulation of the GCC clause 4.5.6 of the Contract Agreement Mr. Ajay Kumar Singh is hereby debarred for a period of minimum two years (2 Years) from engagement on NHIDCL/ MORT&H's project of/or to be undertaken by it either directly or indirectly effective from the date of issue of this notice.
