DEBARMENT NOTICE

Subject: Debarment of Sh. Bamdev Rout from engagement on NHIDCL/MoRTH projects for 02 years as per GCC Clause 4.5.6 of the Contract Agreement.

It is brought to notice of all Division/Units of NHIDCL and other agencies of MoRTH that Mr. Bamdev Rout was appointed as "Senior Quality cum Material Expert" by M/s Consulting Engineers Group Ltd. in Association with M/s Sri Infotech & M/s Shri Kushalsuri Engineering Services Pvt. Ltd. for the work of Consultancy Services for Authority's Engineer for supervision of "(i) Improvement/widening to two laning with earthen shoulder of Nongjri (Design Ch. 30.00 km) to Maheshkhola (Design Ch, 55.525 km) [R-M-B Package-II] on SH-4 section from Ranikor-Maheshkhola-Baghmara Project in the State of Meghalaya on EPC basis (ii) Improvement/ widening to two-laning of stretch from 55.525 to km 79.680 of Ranikor-Maheshkhola-Baghmara in the State of Meghalaya under "SARDP-NE" Phase-A on EPC mode [R-M-B Package-III] & (iii) Improvement/ widening to two-laning with earthen shoulder of Panda (Design Ch. 112.300 km) to Baghmara (Design Ch. 129.385 km) [R-M-B Package-VI] on SH-4 section of Ranikor-Maheshkhola-Baghmara Project in the State of Meghalaya on EPC basis" on 02.11.2022, which was the appointed date of the Authority Engineer.

2. Mr. Bamdev Rout the replaced candidate to the original Senior Quality cum Material Expert didn't join the project site due to personal reasons, despite of their consent for joining the in the said position and receiving the approval from the Competent Authority on 06.03.2023.

3. Therefore, as per stipulation of the GCC clause 4.5.6 of the Contract Agreement Mr. Bamdev Rout is hereby debarred for two years (2 Year) from engagement on NHIDCL/MORT&H's project of/or to be undertaken by it either directly or indirectly effective from the date of this circular. This shows the casual approach of Mr. Bamdev Rout in aiding the execution the subject work when time is the essence of the Contract.
