It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that Sh. Devi Singh Kushwah was selected as the Bridge/Structural Engineer by M/s Technocrats Advisory Services Pvt. Ltd. in Association with M/s. JR Consultancy Services pvt. Ltd. (TASPL) for the work Consultancy Services as Authority's Engineer for Supervision of Up-gradation of NH-301 Kargil-Zaskar Road (pkg-4, 5, 6 & 7) in the UT of Ladakh.

2. M/s TASPL vide letter no. 1410 dated 03.01.2022 has informed that Mr. Devi Singh Kushwah, Bridge/Structural Engineer is not interested to join the site.

3. Therefore, as per clause 4.5.2 and 4.5.6 of Contract Agreement, Sh. Devi Singh Kushwah is hereby debarred/blacklisted from participating in future projects of NHIDCL/MoRTH for a period of 02 years from the date of issue of this notice.
