Ltd for the work of Consultancy Services for Authority's Engineer for Supervision of (i) Widening to 2 (Two) Lane with Paved shoulder of Imphal to Jiribam section of NH 37 from Design Chainage 3.275 km to 15.940 Km (Total length=12.665 Km) (PKG-1) in the State of Manipur on Engineering, Procurement & Construction (EPC) mode.(ii) Widening to 2 (Two) Lane with Paved shoulder of Imphal to Jiribam section of NH-37 from Design Chainage 15.940 km to 33.120 Km (Total length=17.180 Km) (PKG-2) in the State of Manipur on Engineering, Procurement & Construction (EPC) mode.
