**Sub: Debarment of Sh. Kamlesh Kumar Pal from engagement on NHIDCL Projects for two years.**

It is bought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Kamlesh Kumar Pal was appointed as Senior Quantity Surveyor by M/s Nippon Koei Ltd in JV with M/s STUP Consultants Pvt. Ltd. In association with M/s Nippon Koei India Pvt. Ltd. for the work of Consultancy Services for Authority's Engineer for "Widening and Up-gradation to 2-lane with paved shoulder configuration and geometric improvements of NH-54 in the State of Mizoram from Km 8.000 to Km 125.000 (Section-1: Civil Contract Packages-1 and 2) on Engineering, Procurement, and Construction (EPC) mode, with Japan International Cooperation Agency (JICA) loan assistance.

2. Sh. Kamlesh Kumar Pal has not joined the duty even after receiving directions of the Employer, i.e. NHIDCL. He was served a mobilization letter by NHIDCL PMU-Seling on 30.09.2020. However, instead of joining, the Authority's Engineer vide letter dated 09.11.2020 requested for further replacement.

3. Therefore, as per stipulations of the Contract Agreement, Sh. Kamlesh Kumar Pal is hereby debarred for two years from engagement on NHIDCL's projects of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
