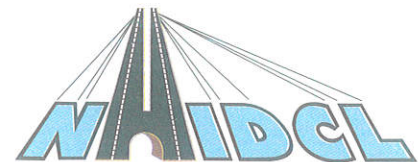

Nitin Tiwari was selected as the 'Road Safety Expert' by M/s Dhruv Consultancy Services Limited in association with M/s M S Consultant for the work of Consultancy Services for Authority's Engineer for Supervision Of (i) Widening /Improvement to 2 (Two) Lane with Earthen Shoulder of Yaingangpokpi-Finch Corner Section from km 0.00 to km 16.900 (length 16.900km) of NH 202 in the State of Manipur on EPC mode. (ii) Widening /Improvement to 2 (Two) Lane with Earthen Shoulder of Yaingangpokpi-Finch Corner Section from km 16.900 to km 30.970 (length 14.070km) of NH 202 in the State of Manipur on EPC mode.
