DEBARMENT ORDER

Subject: Debarment of Sh. P C Bardhan from engagement on NHIDCL/MORT&H projects for 2 years (24 months).

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that **Sh. P C Bardhan** was appointed as “**Team Leader cum Senior Highway Engineer**” by M/s Yongma Engineering Co. Ltd. in association with Sterling Indo Tech Consultants Pvt. Ltd. for the work of Consultancy Services for Authority’s Engineer for Supervision of “Construction of four/six laning from Km 132.375 to Km 153.058 (Total New Alignment length of 20.683 Km) of Daboka Dimapur Section (Dimapur Bypass) of NH-36 & NH-39 in the state of Nagaland and Dimapur Bypass (Assam portion) from existing Km 159.340 of NH-36 to existing Km 102.500 of NH-39 and upto end point of Assam portion (Design Km 118.050 to Design Km 132.375) (length 14.325 Km) in the state of Assam under SARDP-NE on EPC mode.

2. Sh. P C Bardhan has been contacted several times but he is showing his inability to join the project site after providing his consent for the subject project, thereby violating the TOR clause 11.2 of the Contract Agreement.

3. Therefore, as per stipulations of the TOR clause 11.2 of the Contract Agreement, Sh. P C Bardhan is hereby debarred for 2 years (24 months) from engagement on NHIDCL/MORT&H’s project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
