It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that Mr. Radha Kant Upadhyay was selected as the Resident cum Highway Engineer by M/s Magot Engineering Pvt. Ltd, JV with Technical Consultancy Services in Association with Sofi Infrastructure Pvt. Ltd. for the work Consultancy Services as Authority's Engineer For Supervision of (I) Construction & Upgradation to 2-lane /4lane with paved shoulder from Design Km 148+589 (Existing km 235+070) (Vailoo)to Design Km 176+532 (Existing km 263+070) Donipawa of 27.943 km length on Khellani-Khanabal section (Pkg-VI) (II) Construction of New 2-Lane bypass from Design km 176+532(Existing km 263+070) (Donipawa) on NH-244 to Design Km 185+002 (Near Khudwani on NH-44 at existing km 238+500)(Ashajipora) of 8.470km length i.e. to connecting NH-244 & NH-44 (Pkg-VII) & (III) Strengthening & Upgradation of existing carriageway to intermediate lane from Km.0.00 to Km.42.820 of length 42.820 Kms on Baramulla-Gulmarg section of NH-701A in the Union Territory of Jammu & Kashmir on EPC mode.

2. M/s Magot Engineering Pvt. Ltd, JV with Technical Consultancy Services in Association with Sofi Infrastructure Pvt. Ltd. vide letter no. 6489 dated 03.02.2022 has informed that Mr. Radha Kant Upadhyay, Resident cum Highway Engineer is unfit to join the site.
