**CIRCULAR**

Sub: Debarment of Sh. Sunil Kumar Singh from engagement on NHIDCL Projects.

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Sh. Sunil Kumar Singh was appointed as Senior Quantity Surveyor by M/s Nippon Koei Ltd in JV with M/s STUP Consultants Pvt. Ltd. In association with M/s Nippon Koei India Pvt. Ltd. for the work of Consultancy Services for Authority's Engineer for "Widening and Up-gradation to 2-lane with paved shoulder configuration and geometric improvements of NH-54 in the State of Mizoram from Km 8.000 to Km 125.000 (Section-1: Civil Contract Packages-1 and 2) on Engineering, Procurement, and Construction (EPC) mode, with Japan International Cooperation Agency (JICA) loan assistance.

2. Sh. Sunil Kumar Singh committed serious misconduct i.e. he was found missing from the "Home Quarantine" facility & run away from the State of Mizoram on account of him being COVID-positive without any knowledge of the Authority as well as the Govt. Of Mizoram which has jeopardized the cordial relations of NHIDCL and Govt. of Mizoram in getting 'Inter-State Movement' permissions of other NHIDCL, Contractors and Consultants etc. He was terminated by NHIDCL PMU-Seling on 30.09.2020 for serious misconduct & abandoning the project.

3. Therefore, as per stipulations of the Contract Agreement, Sh. Sunil Kumar Singh is hereby Debarred for two year from engagement on NHIDCL's projects of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
