Ltd. for the work of Consultancy Services for Authority's Engineer for Supervision of "Construction of four/six laning from Km 132.375 to Km 153.058 (Total New Alignment length of 20.683 Km) of Daboka Dimapur Section (Dimapur Bypass) of NH-36 & NH-39 in the state of Nagaland and Dimapur Bypass (Assam portion) from existing Km 159.340 of NH-36 to existing Km 102.500 of NH-39 and upto end point of Assam portion (Design Km 118.050 to Design Km 132.375) (length 14.325 Km) in the state of Assam under SARDP-NE on EPC mode.
