DEBARMENT ORDER

Subject: Debarment of Shri Dipu Dutta, the than Deputy General Manager (Projects) NHIDCL Site Office Singngat, (PMU-Churachandpur) under Regional office-Imphal, Manipur for engagement in NHIDCL and in any projects under execution by NHIDCL, either through the EPC Contractors or Consultancy firms working in NHIDCL projects.

It is brought to notice of all the divisions/units of NHIDCL and other agencies of MoRT&H that Shri Dipu Dutta, has joined NHIDCL Site Office Singngat, (PMU-Churachandpur) under Regional office-Imphal, Manipur in the capacity of Deputy General Manager (Projects) on Contract basis in accordance with NHIDCL Office Order dated 17.03.2021 for supervision of NHIDCL projects of NH-102B, Widening to 2 (Two) Lane with Hard shoulder of Churachandpur to Tuivai section of NH 102B (Packages IA, IIB, IIA, IIB, III, IVA & IVB) in the State of Manipur on EPC mode in the State of Manipur.

- 2. Whereas, Shri Maman Chand Bansal, Special Project Monitor inspect the project site, of Widening to 2 (Two) Lane with Hard shoulder of Churachandpur to Tuivai section of NH 102B (Packages IIB, IVA & IVB) in the State of Manipur on EPC mode between the period 04.06.2022 and 11.06.2022 and vide his report dated 23.06.2022 has reported the matter of over payments in Project, Package-IVA & IVB.
- 3. Whereas vide OM No. NHIDCL/SPM/Manipur/2022-23 dated 8th August 2022, a committee with following members was constituted for inspecting, factual verification, investigating, examination of a complaint pertaining to the works of Manipur on NH-102 B. The Committee comprised of (i) Sh. D.S. Chaudhary, ED(P), RO, Imphal, (ii) Sh. Mahesh Gupta, Dy.GM(F) and (iii) Sh. Devender Kumar, Dy.GM(T), NHIDCL, Hqrs Office, New Delhi.
- 4. Whereas the Committee visited the site on 17th to 18th August 2022 in the presence of Authority's Engineer and NHIDCL officials of RO Imphal, PMU Churachandpur, Site office Singhat/ Singngat and the representatives of the Contractor. The Committee inspected the records at the office of the Authority Engineer on 19th August 2022. The Committee during inspection noted overpayments of Rs. 50.51 crore and price adjustments thereon in two (Package-IVA and IV B).
- 5. NHIDCL vide O.M. No. NHIDCL/SPM/Manipur/2022-23/212418/3150 dated 21.09.2022 & no. 3156 dated 22.09.2022, had served the Show Cause Notice to Shri Dipu Dutta, Deputy General Manager (Projects), Site Office-Singhat, Manipur for which reply was submitted by himself vide letter dated 22.09.2022.
- 6. After examination of the reply to the Show-cause, NHIDCL had issued a Charge Sheet to Sh. Dipu Dutta, the than DGM(P) SO-Singngat vide Memorandum No. NHIDCL/SPM/Manipur/2022-23/3212 dated 08.11.2022 for which Sh. Dipu Dutta has submitted his written statement against the charges vide letter dated 18.11.2022, which has been examined and found unsatisfactory. Therefore, he can't be absolved of his duties as a representative of Authority as the than Deputy General Manager (Projects) SO-Singngat.
- 7. Shri Dipu Dutta the then Deputy General Manager, (Projects) SO-Singngat, Manipur has not followed the roles & responsibilities as defined in the EPC Contract Agreement signed between NHIDCL & M/s GPT Infraprojects Limited & committed gross negligence.

- 8. In light of the above, Shri Dipu Dutta the then Deputy General Manager, (Projects) SO-Singngat, Manipur is hereby hereby debarred for engagement in NHIDCl and in any projects under execution by NHIDCL, either through the EPC Contractors or Consultancy firms working in NHIDCL projects.
- 9. This Debarment order is issued without prejudice to any other right or remedy available with the Authority under the Contract Agreement and / or applicable law.
