Debarment Notice

It is brought to notice of all the Divisions/Units of NHIDCL and other agencies of MoRT&H that Shri Kshiti Sundar Roy was appointed as Material Engineer by M/s Yongma Engineering Co. Ltd in association with M/s Sterling Indo Tech Consultants Pvt. Ltd. for the work of Consultancy Services for Authority's Engineer for Supervision of "Construction of four/six laning from Km 132.375 to Km 153.058 (Total New Alignment length of 20.683 Km) of Daboka Dimapur Section (Dimapur Bypass) of NH-36 & NH-39 in the state of Nagaland and Dimapur Bypass (Assam portion) from existing Km 159.340 of NH-36 to existing Km 102.500 of NH-39 and upto end point of Assam portion (Design Km 118.050 to Design Km 132.375) (length 14.325 Km) in the state of Assam under SARDP-NE on EPC mode

2. Shri Kshiti Sundar Roy due to his inefficiency/incompetence/misconduct was replaced inspite of approval of his CV after providing his consent to remain in the subject project(s) for its entire duration, thereby violating the TOR clause 11 of the Contract Agreement.

Therefore, as per stipulations of the TOR clause 11 of the Contract Agreement, Shri Shri Kshiti Sundar Roy is hereby debarred for 24 (Twenty-Four) months from engagement on NHIDCL/MORT&H's project of/or to be undertaken by it either directly or indirectly effective from the date of this circular.
