Subject: Debarment of Retd. Col. Rajeev Sood, the than Executive Director (Projects) NHIDCL Regional Office at Imphal, Manipur engagement in NHIDCL and in any projects under execution by NHIDCL, either through the EPC Contractors or Consultancy firms working in NHIDCL projects.

It is brought to notice of all the divisions/units of NHIDCL and other agencies of MoRT&H that Retd. Col. Rajeev Sood, has joined NHIDCL Regional Office at Imphal, Manipur in the capacity of Executive Director (Projects) on Contract basis in accordance with NHIDCL Office Order dated 28.02.2020 for overall supervision of NHIDCL projects in the State of Manipur.

Whereas, Shri Maman Chand Bansal, Special Project Monitor inspect the project site, 2. of Widening to 2 (Two) Lane with Hard shoulder of Churachandpur to Tuivai section of NH 102B (Packages - IIB, IVA & IVB) in the State of Manipur on EPC mode between the period 04.06.2022 and 11.06.2022 and vide his report dated 23.06.2022 has reported the matter of over payments in Project, Package-IVA & IVB.

Whereas vide O.M. No. NHIDCL/SPM/Manipur/2022-23 dated 8th August 2022, a 3. committee with following members was constituted for inspecting, factual verification, investigating, examination of a complaint pertaining to the works of Manipur on NH-102 B. The Committee comprised of (i) Sh. D.S. Chaudhary, ED(P), RO, Imphal, (ii) Sh. Mahesh Gupta, Dy.GM(F) and (iii) Sh. Devender Kumar, Dy.GM(T), NHIDCL, Hgrs Office, New Delhi.

Whereas the Committee visited the site on 17<sup>th</sup> to 18<sup>th</sup> August 2022 in the presence 4. of Authority's Engineer and NHIDCL officials of RO Imphal, PMU Churachandpur, Site office Singhat and the representatives of the Contractor. The Committee inspected the records at the office of the Authority Engineer on 19<sup>th</sup> August 2022. The Committee during inspection noted overpayments of Rs. 50.51 crore and price adjustments thereon in two (Package-IVA and IV B).

NHIDCL vide O.M. No. NHIDCL/SPM/Manipur/2022-23/212418/3144 dated 21.09.2022 5. & no. 3154 dated 22.09.2022, had served the Show Cause Notice to Shri Rajeev Sood, the then Executive Director (Projects), Regional Office-Imphal, Manipur for which reply was submitted vide letter dated 27.09.2022.

6. After examination of the reply to the Showcause, NHIDCL had issued a Charge Sheet Sood. the than Executive Director vide Memorandum to Sh. Raieev No. NHIDCL/SPM/Manipur/2022-23/3211 dated 08.11.2022 for which charges framed against him has not been denied as well as he can't be absolved of his duties as a representative of Authority as the than Executive Director (P) RO-Imphal.

Shri Rajeev Sood the than Executive Director (P) RO-Imphal has not followed the 7. roles & responsibilities as defined in the EPC Contract Agreement signed between NHIDCL & M/s GPT Infraprojects Limited & committed gross negligence.

8. In light of the above, Shri Rajeev Sood the than Executive Director (P) RO-Imphal is hereby debarred for engagement in NHIDCL and in any projects under execution by NHIDCL, either through the EPC Contractors or Consultancy firms working in NHIDCL projects.

9. This Debarment order is issued without prejudice to any other right or remedy available with the Authority under the Contract Agreement and / or applicable law.
