Heard Shri I. Choudhury, learned Senior Counsel assisted by Shri S. Biswakarma, learned counsel for the petitioners.

The petitioners are aggrieved by an order dated 23.01.2023, issued by the National Highway Infrastructure Development Corporation Limited (NHIDCL) by which the petitioners have been debarred for two years from participating in any future projects of the NHIDCL or of the Ministry either directly or indirectly.

According to the respondents, the said order was preceded by a Show Cause Notice dated 26.09.2022.

The learned Senior Counsel for the petitioners by referring to the communication dated 26.09.2022 submits that by no stretch of imagination, the same can be construed to be a Show Cause Notice and therefore, the petitioners were deprived of an effective opportunity to place its case before the impugned debarment notice was issued.

Issue notice, returnable by 6 (six) weeks.

Shri R.K. Talukdar, learned Standing Counsel, NHIDCL accepts notice on behalf of all the respondents.

Extra copies of the writ petition be served upon Shri Talukdar, the learned counsel by tomorrow, i.e. 02.02.2023.

Shri Choudhury, the learned Senior Counsel prays for an interim order. At

the same time. Shri Talukdar, the learned counsel for the respondents raises a preliminary objection on questioning the maintainability of the writ petition on the ground of availability of alternative remedy in the form of an arbitration.

The aforesaid submission would be considered at an appropriate stage.

Till the returnable date, the impugned communication dated 26.09.2022 of debarment shall remain suspended.

Heard Shri S. Biswakarma, learned counsel for the applicants / writ petitioners whereas Shri RK Talukdar, learned Standing Counsel is present for the NHIDCL.

2. By this application, a correction has been sought for in the order dated 01.02.2023 passed in WP(C)/496/2023 regarding the date of the impugned communication. In the penultimate paragraph, while passing an order for interim stay, this Court has referred the date of impugned communication to be 26.09.2022. For ready reference, the said observation is extracted hereinbelow:

*“Till the returnable date, the impugned communication dated 26.09.2022 of debarment shall remain suspended.”*

3. The date of communication however should be 23.01.2023 which is apparent from the second paragraph of the order.

4. In view of the above, the order dated 01.02.2023 passed in WP(C)/496/2023 stands corrected by observing that the date appearing in the second last paragraph of 26.09.2022 be read as 23.01.2023. For all practical purpose, a copy of this order be treated as part of the order dated 01.02.2023.

5. The application accordingly stands disposed of.
