Reference is invited to the Debarment Notice issued vide this office letter no. 1557 dated 29.04.2022, wherein, Mr. Ramasubbaraju K was debarred/blacklisted from participating in future projects of NHIDCL/MoRT&H for a period of 2 years from 29.04.2022.

2. The Consultancy firm M/s. FEEDBACK INFRA in association with M/s Armenge Engg & Management Consultants Pvt. Ltd. has informed that Mr. Ramasubbaraju K has reported back to the firm for further duties as he has now recovered from his illness. Mr. Ramasubbaraju K has submitted medical certificate duly signed by Civil Surgeon stating that due to medical reasons, he had left the assignment with no malice intention and is now available for the project.

3. Considering the above fact, it is proposed to withdraw the debarment of Mr. Ramasubbaraju K so that the key person may join the project "Widening/Improvement to 4 (Four) Lane with Paved Shoulder of Daboka - Khatkhathi stretch of NH-29 of Package 5 starting from Near Ganpath Gaur Gaon at Km 95+400 to Kwaram Taro village at Km 113+330 (Design KM 96+400 to Km 113+830) in the state of Assam on EPC mode" under NH(O)-NE" under the same consultancy firm.

4. In light of the above, with the approval of the Competent Authority, the debarment notice issued vide letter no. 1557 dated 29.04.2022 stands withdrawn with immediate effect.
