Considering the above fact, it is proposed to withdraw the debarment of Mr. Ramasubbaraju K so that the key person may join the project "Widening/Improvement to 4 (Four) Lane with Paved Shoulder of Daboka - Khatkhati stretch of NH-29 of Package 5 starting from Near Ganpath Gaur Gaon at Km 95+400 to Kwaram Taro village at Km 113+330 (Design KM 96+400 to Km 113+830) in the state of Assam on EPC mode" under NH(O)-NE" under the same consultancy firm.

4. In light of the above, with the approval of the Competent Authority, the debarment notice issued vide letter no. 1557 dated 29.04.2022 stands withdrawn with immediate effect.
