National Highways Infrastructure Development Corporation Limited (the “Authority”) is engaged in the development of National Highways and as part of this endeavour, the Authority has decided to undertake **Construction for 4 (Four) Lining and Greenfield alignment of Karimganj - Silchar section of NH-37 from Design chainage 0.000 (Near ISBT, Silchar bypass) to Km. 15.970 (Kalinagar Pt I on NH-37) in the state of Assam on HAM mode. Package -I (Length- 15.970 km) Assam on Hybrid Annuity Mode.** Accordingly, Authority has decided to procure Consultancy Services for appointment of Independent Engineer.
