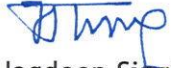
With reference to the RFP for the subject work, the following points are clarified as under:-

1	Bid security is mentioned as 0.304 Crs in NIT (pg 3) but also given as 0.62 crs (Six Lakhs Twenty Thousand Only) in clause 12.2 (d) pg 22. The bid security is generally less than PBG.	As per Corrigendum-I. BID Security is of Rs. 0.061Cr. (Six Lakhs Ten Thousand Only)
2	Secondly, can we submit the Bid security/ PBG in form of Bank Guarantee because in some states E-BG is Not applicable is not been specified in RFP.	Bid security may be submitted in form of Account Payee Demand Draft, Bankers Cheque or Electronic Bank Guarantee (e-Bank Guarantee). PBG may be submitted in form of e-BG only.
3	The work defined as per NIT (pg 3) is 12 months of work and 120 Months of Maintenance (i.e. 11 years), whereas per pg 247 Routine maintenance is calculated on 60 months, further to inform you the same we have bidded for similar projects in other organizations and the project of PBMC is for 05 years including maintenance as per Mort&H guidelines	As per Corrigendum-I, Contract duration is 60 Months
4	Thirdly, the PR works has Maintenance of 03 years only as per Mort&H guidelines.	As per Corrigendum-I
5	Fourthly, the item no 1.05 as per BOQ structure repair works quantum of items / nature of works has not been defined in RFP.	It is hereby informed that all structures falling within the project area shall be repaired or restored as per the approved standards and specifications. Additionally, the list of the assets are specified in Section 10 of the RFP.
