

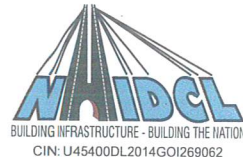

2. Further, the RFP Clause 2.2.2(BB) is modified as under:-

(BB) Bidder who inter-alia meet the minimum qualification criteria will be qualified only if their available Net Worth is more than or equal to the required Net Worth value (value as per clause 2.2.2(B)). The available Net worth will be assessed as per following, based on information mentioned at Annexure-VIII of Appendix-IA.

Assessed Available Net Worth= (A-B*20%), where

A= Net worth of the bidder.

B= Balance value of existing commitments, PPP works for which the bidder has emerged as the winner of the bids or on-going works to be completed during the period of completion of the works for which BID is invited. For the avoidance of

doubts, it is clarified that works for which bidder has emerged as the winner of the bids but LOA has not been issued as on the date before opening of Financial Bids shall also be considered while calculating value of B.

The status of Assessed Available Net Worth of the bidder to be updated as on the date before opening of the financial bids.
