The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of the bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more. iv. The additional performance security shall be treated as part of the performance security.
