To all the Prospective Bidders

In reference to the NIT and RFP uploaded on CPPP on 27.12.2024 for the work "One Time Improvement of Ukhrul-Toloi-Tadubi road (i.e., Existing Ukhrul Town/Bypass, Road) section from Km 0.00 to Km 09.00 covering 9.00 Km length on NH-102A in the state of Manipur in the FY-2024-2025 on EPC mode."

2. It is informed to all the prospective bidders that the following amendment is made to the Corrigendum-I issued on 08.01.2025:

Sl No.	Additional Criteria added in Corrigendum-I	Modified/Amendment
1.	the potential bidder must either own or have secured assured ownership of a Hot Mix Plant with a minimum capacity of 80 to 100 TPH Capacity, as well as a Wet Mix Macadam (WMM) Plant of adequate capacity, conforming to Section 406.3.3 of the MoRT&H Specifications for Road & Bridge Works (Fifth Revision). These plants must be in full working condition, and the bidder must demonstrate their availability within a 50 km radius of the project site which in turn shall be inspected by the DGM(P)/GM(P), PMU Ukhrul and the inspection report will be part of the Technical Evaluation. In case, the bidders fail to demonstrate the same at site, they shall be summarily declared as Non-Responsive	The Criteria, as mentioned in Corrigendum-I, has been hereby removed.

All prospective bidders are advised to take note of this amendment and submit their bids accordingly.

3. The rest of the terms and conditions remain unchanged. Any further amendments or clarifications will be communicated as needed.
