#### **Project Completion Schedule**

#### 1. Project Completion Schedule

During Construction period, the Contractor shall comply with the requirements set forth in this Schedule-J for each of the Project Milestones and the **Scheduled Completion Date**. Within 15 (fifteen) days of the date of each Project Milestone, the Contractor shall notify the Authority of such compliance along with necessary particulars thereof.

### 2. Project Milestone-I

- (i) Project Milestone-I shall occur on the date falling on [192<sup>nd</sup>] day from the Appointed Date (the "Project Milestone-I").
- (ii) Prior to the occurrence of Project Milestone-I, the Contractor shall have commenced construction of the Project Highway and submitted to the Authority duly and validly prepared Stage Payment Statements for an amount not less than 10% (ten per cent) of the Contract Price.

#### 3. Project Milestone-II

- (i) Project Milestone-II shall occur on the date falling on the [329th] day from the Appointed Date (the "Project Milestone-II").
- (ii) Prior to the occurrence of Project Milestone-II, the Contractor shall have continued with construction of the Project Highway and submitted to the Authority duly and validly prepared Stage Payment Statements for an amount not less than 35%
- (iii) (thirty-five per cent) of the Contract Price and should have started construction of all culverts and bridges.

#### 4. Project Milestone-III

- (i) Project Milestone-III shall occur on the date falling on the [466th] day from the Appointed Date (the "Project Milestone-III").
- (ii) Prior to the occurrence of Project Milestone-III, the Contractor shall have continued with construction of the Project Highway and submitted to the Authority duly and validly prepared Stage Payment Statements for an amount not less than 70% (seventy per cent) of the Contract Price and should have started construction of all project facilities.

#### 5. Scheduled Completion Date

- (i) The Scheduled Completion Date shall occur on the [548<sup>th</sup> day] from the Appointed Date.
- (ii) On or before the Scheduled Completion Date, the Contractor shall have completed construction in accordance with this Agreement.
