Clause 16(B) of the RFP (Page No. 6 to 8)	As per clause 16 (A). Eligibility criteria for sole applicant firm there is three table 1(a), 1(b) and 1(c) of para A and as per clause 16(B) Eligibility Criteria for partners in case of JV (not more than 1 JV partners shall be allowed):- It is clearly mentioned that the Lead Partner and JV Partner jointly should meet the eligibility criteria mentioned at 1(a) of Table under Para (A), and The Lead Partner should meet the criteria mentioned at 1(b) of Table under Para (A) at page no. 8 of RFP. Our point is that :- However, there is no specific clarification regarding Table 1(c) of Para (A). We therefore request you to kindly confirm whether: The Lead Partner alone should meet the criteria mentioned under Table 1(c) of Para (A), or The Lead and JV Partner jointly can meet the criteria mentioned under Table 1(c) of Para (A). Your clarification on this point will help us ensure full compliance with the eligibility requirements of the RFP.	Refer Corrigendum no.1
