1. The RFP for the above subject work was invited with bid due date on 08.09.2017 till 1500hrs. In all, Three bids were received from the following bidders.

2. The technical bid for the project was opened on 11.09.2017 at 1530 hrs on CPP portal and INFRACON portal. Technical Evaluation is carried out through INFRACON Portal.

3. As per Clause 11. A) of Section-1 of RFP the Eligibility Requirement is the Minimum Annual Average Turnover for the last three Financial Years should be equal to or more than Rs. 15.627 Crore for sole applicant firm. The Average Annual Turnover of 3 years of M/s Chaitanya Projects Consultancy Pvt Ltd is 7.819 Crore. i.e. found not Eligible in First Stage Technical Evaluation and not qualified for Second Stage Technical Evaluation.

4. It was brought to the notice of committee that the INFRACON Portal has evaluation mechanism for 6 Key Personnel which are given in model document of the ministry. Ministry vide letter No RW-NH-34048/7/2013-S&R (B) dated 01.01.2016 directed to include two Key Personnel i.e. Bridge Design Specialist and Highway Design Specialist for the Authority Engineer projects. It is also informed to Committee by member secretary that online evaluation of Bridge Design Specialist can be done on the line of Bridge/Structural Engineer. However online of Highway Design Specialist is not available on the INFRACON. Therefore the CV of Highway Design Specialist is evaluated manually. The Technical score obtained after evaluation through INFRACON Portal as well as manual evaluation of Highway Design Specialist are as under (Complete Evaluation Sheet is at Annexure-I) .
