**Minutes of Meeting** of Empowered Financial Bid Evaluation Committee (EFEC) to evaluate bid for "Two/ Four laning of Imphal-Moreh Section of NH-39 from Km 330.00 to Km 395.680 in the State of Manipur" - Hiring of NGO reg. held at NHIDCL, New Delhi on 29.08.2017.

The RFP for the subject work were invited on 09.03.2017 with bid due date as **24.04.2017** till **1500 hrs.**

2. Consequent upon the opening of the financial bid on 25.04.2017 by ETBC, the ETEC vide minutes of meeting dated 17.08.2017 decided to open the financial bid, three technically qualified bidders viz. **M/s Sai International Sansthan, M/s Janlok Kalyankari Samiti and M/s Manavadhikar Samajik Manch.** Accordingly the financial bid was opened on 28.08.2017 by the Empowered Financial Bid opening Committee (EFBC) in the presence of consultants who choose to attend and the committee recommended to forward the financial bid of aforesaid bidders to financial consultant M/s JPS Associate (P) Ltd for further evaluation.
3. The details of the scores submitted by the financial consultant vide letter dated 29.08.2017 (Annex- I) is tabulated below:

4. The financial consultant recommended that **M/s Sai International Sansthan** may be considered as the selected bidder and accordingly may be invited for negotiations as per the provision of RFP.
5. Further as per Clause 5.8 of section 2 of RFP the NGO achieving the highest rank based on combined technical/ financial score, will be invited for negotiations. Hence in pursuant to Clause 5.8, **M/s Sai International Sansthan** may be called for negotiations.
6. In view of above the committee recommends to invite **M/s Sai International Sansthan** for negotiation with the approval of Competent Authority.
