Detailed Reasons for Non-Responsiveness

1. M/s ABCI Infrastructures Pvt. Ltd.

The bidder needs to submit Appendix - XII i.e. Certificate regarding Compliance with Restrictions under Rule 144 (xi) of the General Financial Rules.

2. M/s JSC BUER- M/s NSCPL (JV)

As per clause 2.11.2 (i) of RFP, foreign origin bidder needs to submit original apostille experience certificates physically. However, the bidder has not physically submitted the original apostille experience certificates of the Lead member, M/s JSC Buer as required under clause 2.11.2 (i) of RFP. Therefore, the bidder needs to submit the original apostille experience certificates physically as per Cl. 2.11.2 (i).

3. M/s Skylark Infra Engineering Pvt. Ltd

The bidder is meeting the minimum required criteria for similar work as per clause 2.2.2.2 (ii) of RFP with project code 'H'. The bidder has submitted completion certificate signed by the Authority's Engineer. Though the work has been completed, the bidder shall submit the experience certificate from the project owning department as per the instruction no. 16 under Annexure-IV of RFP. The bidder has been considered provisionally responsive and financial bid shall be opened subject to submission of experience certificate from the client indicating the value of work done for the requirement of similar work experience. Also, as per Annexure-I i.e. Details of Bidder submitted by the bidder in their technical bid states that the bid has been submitted in JV whereas, the POA and all other documents states that the bid has been submitted as a sole bidder. Therefore, bidder needs to submit the clarification/amendment for the same.

4. M/s Rajinder Infrastructure Pvt. Ltd.

The bidder is not meeting the minimum threshold technical capacity as required under Cl. 2.2.2.2 (i) of RFP. The bidder has submitted 08 nos. of projects of Rs. 502 Cr for claiming technical experience under Cl. 2.2.2.2 (i) of RFP. After assessing the threshold technical capacity, the eligible technical experience works out to Rs. 483.85 Cr (02 projects i.e. code-g and code-h are not eligible as the gross amount received is less than 5% of the estimated project cost) against Rs. 502 Cr.

claimed by the bidder. Accordingly, the bidder M/s Rajinder Infrastructure Pvt. Ltd. is non-responsive as per Cl. 2.2.2.2 (i) of RFP.

5. M/s Shivalaya Construction Co. Pvt Ltd.

The bidder is meeting the minimum required criteria for similar work as per clause 2.2.2.2 (ii) of RFP. The bidder has submitted completion certificates signed by the Authority's Engineer. The TEC noted that though the works has been completed, the bidder shall submit the experience certificates from the project owning department as per the instruction no. 16 under Annexure-IV of RFP. The TEC deliberated the matter and decided that the bidder may be considered provisionally responsive and financial bid shall be opened subject to submission of experience certificate from the client indicating the value of work done for the requirement of similar work experience.
