2. On manual scrutiny of the CVs uploaded on INFRACON, it has been observed that consultants and their key personnel's have not filled the details of their CVs properly which is resulting in low scores. Some of the discrepancies which has been observed in their submissions are as under.

- (i) Key personnel's have not mentioned their **date of birth** and other necessary basic details in their CVs.
- (ii) Inappropriate selection of **Major activities** and **Nature of Assignment**.
- (iii) Inaccurate selection of Mode **of Project**.
- (iv) Unfilled **Lane type: 2/4/6 lane** (major input required for evaluation).
- (v) Unfilled **Bridge Length** and **No. of Bridges**.
- (vi) **Arbitration case handled: Yes/No** (Required in Contract specialist evaluation).
- (vii) Other necessary details as required in the evaluation.

3. It is decided to give the consultants an opportunity to fill the necessary details as mentioned above in their CVs already uploaded on INFRACON portal latest by **19.08.2016 (1600 hrs)**. The bids will be then re-evaluated through INFRACON portal again and scores will be updated accordingly and will be communicated to the consultant before opening of financial bids.
