- (v) Unfilled Bridge Length and No. of Bridges.
- (vi) Arbitration case handled: Yes/No (Required in Contract specialist evaluation).
- (vii) Other necessary details as required in the evaluation.
- 3. It is decided to give the consultants an opportunity to fill the necessary details as mentioned above in their CVs already uploaded on INFRACON portal latest by 19.08.2016 (1600 hrs). The bids will be then re-evaluated through INFRACON portal again and scores will be updated accordingly and will be communicated to the consultant before opening of financial bids.
