Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) for evaluation of Technical Bids for the work "Selection of agency for operation and running of Canteen over the terrace of the Automated Multilevel Car Parking Building, Transport Bhawan, 1-Parliament Street, New Delhi-110001 (2nd Call)" at NHIDCL HQ, New Delhi on 31.01.2019.

Consequent to the recommendation of ETEC vide Minutes of Meeting dated 17.01.2019 (*Annexure I*) and further approval of the Competent Authority, the bidders **M/s Tasty Foods** and **M/s Cuisines Caterers & Hospitality Services** (A unit of Shrinivas Hospitality Management Services Pvt. Ltd.) were invited for the PPT presentation to showcase their idea of operation of proposed Café/ Canteen at the roof top of Automated Multilevel Car Parking, as per the provision of RFP.

2. The bidders gave the PPT presentation on 31.01.2019 before the Committee constituted by Director (A&F) to evaluate the PPT presentation. The maximum marks for the PPT presentation was 30, out of which **M/s Tasty Foods** scored 23 marks and **M/s Cuisines Caterers & Hospitality Services** (A unit of Shrinivas Hospitality Management Services Pvt. Ltd.) scored 26 marks. (Scoresheet for PPT presentation is as *Annexure II*).

3. The Committee calculated the final marks of the 02 bidders and found that the final marks scored by **M/s Tasty Foods** is 72 and that of **M/s Cuisines Caterers & Hospitality Services** (A unit of Shrinivas Hospitality Management Services Pvt. Ltd.) is 76 (The final score sheet of the bidders is as *Annexure III*).

4. The Committee opined that since both the bidders have scored more than 70 marks, hence, they are technically qualified and eligible for financial evaluation, as per the provision of RFP.

5. The Committee recommends to open the financial bids of **M/s Tasty Foods** and **M/s Cuisines Caterers & Hospitality Services** (A unit of Shrinivas Hospitality Management Services Pvt. Ltd.) with the approval of the Competent Authority.


