1. The RFP for the above subject work was invited with bid due date on 31.01.2017 till 1700hrs. In all, **Three bids** were received from the following bidders.

2. The technical bid for the project was opened on 31.01.2017 at 1700 hrs on CPP portal and INFRACON portal. Manual evaluation is carried out from the CVs of the firm & Key Personnel's uploaded data at INFRACON Portal.

3. As per clause 13 of RFP, the average annual turnover for three Financial Year should be equal to or more than **10.15 Crore** for qualification for Technical Evaluation. 




5. The average annual Turnover of all the firms are more than Rs. 10.15 Cr.
