\* As all the bidder are meeting criteria under clause 2.2.2.2(ii) of RFP i.e "Provided that at least one similar work of 25% of Estimated Project Cost Rs 313.28 Crore (Rupees Three Hundred Thirteen Crore Twenty Eight Lakh Only) shall have been completed from the Eligible Projects in Category 1 and/or Category 3 specified in Clause 2.2.2.5. For this purpose, a project shall be considered to be completed, if more than 90% of the value of work has been completed and such completed value of work is equal to or more than 25% of the estimated project cost.," Hence no updation has been given on Project Cost of Eligible Projects.

\* \*Out of 10 Projects of bidders, 6 Projects has been considered to evaluate the minimum technical criteria under clause 2.2.2.2 as the bidder meets the minimum criteria.

7. For evaluation purpose, the consultant has taken limited projects fulfilling the minimum eligibility criteria and in calculation of value of B, the consultant has assumed that the projects have been not yet been started and the liability of bidder is 100 % for the project and thus the value of Bid Capacity does not increase, keeping it at a safer side.


8. **Recommendation of the Empowered Technical bid Evaluation Committee (ETEC):** The committee is of the view that all the three bidders are fulfilling the eligibility criteria prescribed in the RFP, therefore the financial bids of all the three bidders be opened with the approval of the Competent Authority.
