Subject-Minutes of Meeting of Empowered Technical Evaluation Committee(ETEC) for evaluating Technical Bids for " Consultancy Services for Feasibility Study, Preparation of Detailed Project Report and providing pre-construction services for up gradation of selected road stretch/corridor to Two lane with paved shoulders NH configuration under BHARATMALA Project and National Highways connectivity to Backward areas/Religious/Tourist places of the country in the state of Arunachal Pradesh" held at NHIDCL on 23.01.2017 (2nd meeting).

1. Committee vide minutes of 1st meeting dated 06.01.2017 has recommended for opening of financial bids of Technically Responsive bidders. Consequent upon Approval of Competent Authority the Technical Score of the bidders along with minutes of meeting were uploaded on the website to submit the clarification/Representation if any by the consultant on or before 16.01.2017.
2. The committee vide para 9 of the said minutes of meeting had noted that the Team Leader of M/s Chaitanya Projects Consultancy Pvt. Ltd. in Association with M/s Agnitio Infrastructure Projects Pvt. Ltd. had scored less than 75 marks accordingly the firm was declared Non-Responsive as per Clause 3.2.4.
3. M/s Chaitanya Projects Consultancy Pvt. Ltd. in Association with M/s Agnitio Infrastructure Projects Pvt. Ltd. vide letter dated 12.01.2017 has represented that the Proposed Team Leader has vast experience in designing and preparation of DPR of Highway Projects and qualifies for the requirement of Subject work as per RFP and enclosed the CV along with certificates of qualification & experience. Secondly, M/s EPTISA SERVICIOS DE INGENIERIA, S.L. vide letter dated 13.01.2017 has also represented that they should get 20 marks instead of 18 towards firm's relevant experience in last 7 years and Highway Engineer should get score of 90.25 instead of 62.
4. The Committee considered & examined the representation of both the firms and findings are tabulated below.

		Consultant has represented that Quantity Surveyor/Documentation is 70 years in all of the similar projects for North-East.	Quantity Surveyor/Documentation Expert cannot be considered as the age for the key personnel is kept 60 years in the RFP. Therefore score evaluated in first meeting remains same.

5. The committee decided to consider marks of Highway Engineer of M/s EPTISA SERVICIOS DE INGENIERIA, S.L. as 89.5 marks instead of 62 marks. Accordingly the score of the firms has been revised and the final Technical Score is as under. Whereas other entities of 1st meeting will remain same.
