1. The RFP for the above subject work was invited with bid due date on 15.02.2017 till 1700hrs. In all, **Five bids** were received from the following bidders.

2. The technical bid for the project was opened on 16.02.2017 at 1730 hrs on CPP portal and INFRACON portal. Manual evaluation is carried out from the CVs of the firm & Key Personnel's uploaded data at INFRACON Portal.

As per Appendix-V of Detailed Evaluation Criteria of RFP the Eligibility Requirement is the Minimum Annual Average Turnover for the last three Financial Years should be equal to or more than Rs. **5 Crore for sole applicant firm and the last 5 Financial Years in case of JV** i.e. Lead Partner in a JV Annual Average Turnover for the last 5 years should be Rs. 3.75 Crore and Other Partner in a JV Annual Average Turnover for the last 5 years should be Rs. 2.5 Crore.
