Minutes of Meeting

Empowered Technical Evaluation Committee (ETEC) met at NHIDCL HQ on 16.03.2017, New Delhi regarding evaluation of bids for Consultancy Services for carrying out feasibility Study, Preparation of DPR and providing pre-construction services in respect of following packages:

- (i) 2 laning with paved shoulder of Churachandpur -Tuivai road section (length- 162Km) on NH-102B in the State of Manipur
- (ii) 2 laning with paved shoulder of Imphal-Jiribam section of NH-37 (NH-53 (length- 220 Km) in the State of Manipur
- (iii) 2 laning with paved shoulder from Tamenglong in Manipur to Peren in Nagaland via LongdiPabram (length-100Km)- Technical Evaluation- reg.

The RFPs for the subject work were invited with bid due date as 13.01.2017 till 1700 hrs.

2. During the meeting of ETBC on 13.01.2017 the committee (ETBC) opened technical bid and handed over the hard copy of the original documents along with the soft copy (as received from E-bidding service portal viz. <u>https://eprocure.gov.in</u>) to the concerned Financial Consultants **M/s. Raj Har Gopal & Co**. for carrying out the evaluation of the Technical Bids as INFRACON during the period of bid evaluation was not updated as per changes in RFP.

3. The following firms were recommended for technical evaluation:

- (i) M/s. C E Testing Company Pvt. Ltd.
- (ii) M/s. L N Malviya Infra Projects Ltd.
- (iii) M/s. Highway Engineer Consultants in Association with Agnitio Infrastructure Projects Pvt. Ltd. (Team 1 & Team 2)
- (iv) M/s S M Consultants. (Team 1 & Team 2)

4. The Financial Consultant submitted the technical evaluation report on 07.03.2017 (Annex-I) for each bidder package wise as per stipulated evaluation criteria mentioned in the RFP. The recommendations of Financial Consultant are as under:

Financial consultant has bought out that "NHAI has issued an office memorandum dated 03.02.2017 vide its office Memorandum No. CMC/Circular/2017/02/01/94736, according to which they have decided not to consider the Consultancy Bid of M/s. L N MALVIYA a copy of the circular, is attached for your kind perusal (Annexure- A). Thus, NHAI has decided not to consider their consultancy bids till the report of 3-CGM Committee (Constituted vide policy circular No. Policy matter Technical (217/2016)) is finalized and approved by Competent Authority of NHAI. As the 3-CGM committee report of NHAI has not been finalized & Approved as brought by financial consultant therefore M/s L N Malviya Infra Projects Pvt. Ltd. may be considered technically qualified as because firm has not been banned by NHAI.

6. Accordingly, in view of report submitted by Financial Consultant Committee recommended that the bids of the four firms namely (i) M/s C E Testing Company Pvt. Ltd.(ii) M/s. L N Malviya Infra Projects Ltd.(iii) M/s. Highway Engineer Consultants in Association with Agnitio Infrastructure Projects Pvt. Ltd. (iv) M/s S M Consultants. met the Threshold Technical and Financial Capacity, are technically responsive in terms thereof. The Committee, therefore, recommend that the Financial Bid of the following bidders may be opened for above mentioned packages (three) with the approval of the Competent Authority:

- (ii) M/s L N Malviya Infra Projects Ltd.
- (iii) M/s Highway Engineer Consultants in Association with Agnitio Infrastructure Projects Pvt. Ltd.
- M/s S M Consultants. (iv)
