3 The hard copies of the bids were opened and after verification of PoA and DSC details the online bids were also opened and verified. 4. The Financial Consultant M/s KRA & Co. during preliminary RFP evaluation found that some of the data/information provided by 1 Bidder namely M/s Shivalaya Construction Co. Pvt. Ltd. is inadequate or requires clarification for further evaluation. It is proposed by the Financial Consultant to seek clarification from the Bidders before further evaluation. 4. The Financial Consultant during evaluation found that some of the data/information provided by the Bidders are not adhering to the clauses given in the RFP document, so it was proposed that the clarification may be sought from the Bidders as per clause no 3.1.4 of the RFP to facilitate the evaluation process. The financial consultant has stated that the Technical & Financial and Bid Capacities of all the Bidders will be provided only after receiving the replies from the bidders for the respective queries. Accordingly, the Empowered Technical Evaluation Committee (ETEC) in its 1<sup>st</sup>

meeting held on 15.03.2018 has been of a view that the clarification as requested by the Financial Consultant is to be sought from the respective bidders.

5. Clarifications were sought from the bidders and were handed over to the Financial Consultant for the further evaluation.

6. In Continuation to  $1^{st}$  Meeting of **Empowered Technical Bid Evaluation Committee (ETEC)** held on 15.03.2018, replies received from the bidders, the Evaluation report submitted by the Financial Consultant vide letter no. dated 19.03.2018, were deliberated by the ETEC in  $2^{nd}$  meeting held on 19.03.2018. The remarks of ETEC w.r.t the observations, reply received and the submissions of Financial Consultant are tabulated below.
