4. The Financial Consultant M/s Raj-Har Gopal & Co. during evaluation found that some of the data/information provided by the Bidder M/s Bhartia Infra Projects Ltd. are not adhering to the clauses given in the RFP document, so it was proposed that the clarification may be sought from the Bidder as per clause no 3.1.4 of the RFP to facilitate the evaluation process. Accordingly, the queries were sent to bidder by E-Mail dated 24.03.2018.

5. Clarifications were sought from the bidders on mail dated 26.03.2018 and replies received were sent/handed over to the Financial Consultant for the further evaluation.

6. In Continuation of replies received from the bidders, the Evaluation report submitted by the Financial Consultant vide letter no. dated 26.03.2018 were deliberated by the ETEC meeting held on 26.03.2018. The remarks of ETEC w.r.t the observations, reply received and the submissions of Financial Consultant are tabulated below.
