**Subject-Minutes of Meeting of Empowered Technical Evaluation Committee(ETEC) for evaluating Technical Bids for " Consultancy Services for Authority's Engineer for Supervision of Rehabilitation of Churachandpur-Tuivai Road Section (Length-161.48 Km) on NH-102B in the state of Manipur on EPC basis"** held at NHIDCL on 26.12.2016.

1. The REP for the above subject work was invited with bid due date being **25.11.2016** upto **1700 hrs.** In all, **four bids** were received from the following bidders.

2. The hard copy of the original documents along with the soft copy (as received from E-bidding service viz. <https://eprocure.gov.in/cppp/>) were handed over to Financial Consultant for carrying out the evaluation of the Technical Bids. The Financial Consultant had submitted the preliminary RFP evaluation report in respect of each bidder, based on the stipulated evaluation criteria mentioned in the RFP. In the preliminary report, Consultant had recommended certain clarifications regarding experience certificate and Turnover from some of the bidders.

3. Accordingly, the clarifications have been sought from **M/s Indian Technocrat Limited, M/s L.N. Malviya Infra Projects Pvt. Ltd.** and **M/s Unihorn India Private Limited.** The Clarification received from bidders were forward to the Financial Consultant for further evaluations. Financial Consultant **M/s GIANENDER & Associates** vide letter dated 23.12.2016 has submitted final Technical Evaluation Report (Annexure-I).

4. The Financial consultant has also stated that as per evaluation **M/s Indian Technocrat Limited** was considered as Non-Responsive. The following are the reasons for Non-Responsive.

(i) As per the minimum eligibility criteria as defined in clause 11 (A) under section 1 of RFP experience of aggregate length equal to **322.96 Km** for preparation of detailed Project Report/ Feasibility Study cum Preliminary Design Report of 2/4/6 laning/Bridge Project is required whereas the bidder has experience of aggregate length equal to **301.05 km only.**

(ii) As per the minimum eligibility criteria as defined in clause 11 (A) under section 1 of RFP experience of aggregate length equal to **484.44 Km** for Supervision/Independent Engineer/Authority Engineer of 2/4/6 laning/Bridge Project is required whereas the bidder has experience of aggregate length equal to **262.768 km only.**





5. The status of eligibility provided by the Financial Consultant is tabulated below.

6. All the Key personnel's of M/s Highway Engineering Consultants in Association with Agnitio Infrastructure Project Pvt. Ltd. score more than 75% marks.

7. All the Key personnel's of M/s Unihorn India Private Limited score more than 75% marks.

8. One Key personnel of M/s L.N. Malviya Infra Projects Pvt. Ltd i.e. Resident Engineer could not score the minimum Qualifying marks of 75%. NHIDCL may ask to give a replacement for the key personnel who has scored less than 75 % marks from M/s L.N. Malviya Infra Projects Pvt. Ltd if it becomes the preferred bidder. No reduction in remuneration would be made on account of above change.

9. In view of above, the committee recommends for opening of financial bids of following bidders by giving 7 days time and to communicate the Technically responsive bidders their Technical score for Clarification/Representation if any by uploading on website.
