Hence, the bidder is required to submit the clarification how is responsive as per RFP in view of the guidelines issued by the department of disinvestment vide OM dated 13 July, 2001, which is part of the RFP (Annexure-VI).</p> <p>(v) M/s NKG Infrastructure Ltd. has submitted scan copy of Physical Bank Guarantee in the bid document on CPPP though as per RFP, physical BG was not allowed. However, Ministry's circular dated 31.05.2023 allowed submission of Physical Bank Guarantee subject to submission of original BG within 5 days of Bid due date. | (iii) | M/s Power Mech Projects Ltd. | <p>(i) of Power of Attorney and the date of Notarization are not mentioned in Appendix-III.</p> <p>(ii) As per Annexure-II, project codes a to i, k, l, o & p are category-4 projects. However, as per Annexure-IV, project code 'j' has also been mentioned as category-4 project. So only 2 projects i.e. project codes 'm' & 'n' are category-3 projects as per Annexure-IV but not eligible for claiming similar work experience under clause 2.2.2.(AA) of RFP since these projects are not completed up to 90% of the value of work as per submission made by the bidder.</p> <p>Moreover, whether the project code 'j' falls under category-3 as mentioned in Annexure-II lacks clarity w.r.t. the value of works executed under construction/ reconstruction of tracks as required under clause 2.2.2.5 of RFP for category-3 projects since it involves construction of staff quarters also.
