Annexure

Detailed Reasons for Non-Responsiveness

1. M/s Pushpas Construction Pvt Ltd

The bidder, M/s Pushpas Construction Pvt Ltd does not have a similar work of RCC Box Cell as required under clause 2.2.2.2 (iii) (c) of RFP. Accordingly, the bidder, M/s Pushpas Construction Pvt Ltd is non-responsive as per clause 2.2.2.2 (iii) (c) of RFP.

2. M/s Tachu- YFC(JV)

The bid capacity of M/s YFC has been assessed as (-ve) Rs.128.97 Cr. against the requirement of Rs. 83.31 Cr. as per clause 2.2.2.1 of RFP. Therefore, the bidder M/s Tachu-YFC (JV) is non-responsive as per clause 2.2.2.1 of RFP.

3. M/s KKB-JJC(JV)

The bidder, M/s KKB-JJC(JV) fails to meet the minimum 20% of the Project cost i.e. 16.66 Cr. Further, in the experience certificate of similar work the cross sectional area has not been mentioned. Therefore, the bidder M/s KKB-JJC(JV) is non-responsive as per clause 2.2.2.2 (iii) (c) of RFP.

4. M/s Phoenix Engineering and RAK Project Pvt Ltd (JV)

M/s Phoenix Engineering does not fulfil the Threshold Technical capacity as required under clause 2.2.2.2 (i) and 2.2.2.4 (i) of RFP. The lead member has submitted 08 nos. of projects of Rs. 51.75 Cr. for claiming technical experience under Cl. 2.2.2.2 (i) of RFP. After assessment, the total eligible technical experience works out to be Rs. 16.49 Cr against the minimum requirement of Rs. 40.509 Cr. Also, the pages containing value of B in the bid of M/s Phoenix Engineering to calculate the bid capacity is not legible.

Further, the other member, M/s RAK Projects Pvt. Ltd. does not fulfil the minimum net worth as required under Clause 2.2.2.3 (i) and 2.2.2.4 (i) of RFP. The JV member has claimed net worth for the F.Y. 2022-23, whereas its lead member has claimed net worth for financial year 2021-22. Accordingly, FY 2021-22 has been considered for evaluation. As such, the JV member has net worth of Rs. (-) 4.34 Cr. in the F.Y. 2021-22 against the requirement of Rs. 0.83 Cr.

Therefore, the bidder M/s Phoenix Engineering and RAK Project Pvt Ltd (JV) is non-responsive as per clause 2.2.2.1, 2.2.2.2 (i), 2.2.2.3 (i) and 2.2.2.4 (i) of RFP.

5. M/s Jandu construction India Pvt Ltd

The bidder, M/s Jandu construction India Pvt Ltd fails to meet the requirement of bid capacity as it has bid capacity of Rs.18.25 Cr. against the requirement of Rs. 83.31 Cr. as per clause 2.2.2.1 of RFP. Further, in the experience certificate of similar work, does not mention length of box, area of box and exact amount of box constructed. Therefore, the bidder M/s Jandu construction India Pvt Ltd is non-responsive as per clause 2.2.2.2(iii) (c) and 2.2.2.1 of RFP.
