Detailed Reasons for Non-Responsiveness

1. M/s Brand Eagles

The bidder, M/s Brand Eagles does not have similar work in slop protection works as required under clause 2.2.2.2(iii) (c) of RFP. Further TEC deliberated that the bidder has submitted details of existing commitments ('B') for two projects. However recently the bidder has emerged as L1 bidder in two of the NHIDCL tenders. TEC considered the latest status of existing commitments including these two projects of the bidder and found the bid capacity is (-ve) Rs.189.80 Cr. against requirement of Rs. 59.33 Cr. as per clause 2.2.2.1 of RFP.
