## Expression of Interest for Empanelment of Tunnel Expert

The National Highways & Infrastructure Development Corporation Ltd (NHIDCL) has been mandated for development and maintenance of the National Highways, Bridges, Tunnels and other Infrastructure works like construction of buildings, Multi Modal Logistics Park, Multi-Level car parking, Bus ports, water supply work, waste water management etc. There is need for third party checks/inspection of works for effective monitoring and implementation of Tunnels. NHIDCL therefore feels that the services of officers of the rank of Superintending Engineer (SE) & above for e.g., Chief Engineer (CE), Engineer-in-Chief (E-in-C), Additional Director General (ADG), Director General (DG) who have retired from service can be gainfully utilized including technical personnel from consulting firms, Independent Engineers, PSUs, IITs/NITs.

For this purpose, a panel of Tunnel Expert shall be prepared and empanelled members shall be assigned, various tasks related to NHIDCL Tunnel projects along with study of DPR of Tunnel from time to time as and when required. In addition to this, the technical proposal and issues shall be forwarded to the Tunnel Experts over e-mail, and if required discussed through VC.

The Tunnel Expert shall be qualified civil engineer with experience in the field of supervision and construction of Tunnels. The individual shall have knowledge of relevant Specifications of IRC codes and standards, BIS or other international standards for Tunnels. The individual should also have knowledge of specification & standards followed by Ministry of RT&H, CPWD etc related to infrastructure projects. The detail Eligibility Criteria for Tunnel Expert is as under;

## 1. Tunnel Expert:

- a) Graduate in Civil/Mining Engineering or equivalent from a recognized university.
- b) Total professional experience of at least 20 years.
- c) Professional Experience of at least 15 years in handling major tunnelling projects
- d) He should be involved in at least 10 years in construction/construction supervision of major Road/Rail/Metro tunnel projects.
- e) At least 5 years' experience in supervision of tunnel projects of length equal to or more than 4 km of tunnel.
- f) He should have handled at least two projects in Construction Supervision of tunnels projects of length equal to or more than 4 km of tunnel.
- g) Experience in tunnel design/DPR preparation/feasibility study/design review of transportation Tunnel projects of length equal or more than 4 Km.

Also, for Tunnel Monitoring & instrumentation part, domain experts from Computer Science/ Instrumentation Engineering with similar experience in tunnel instrumentation & monitoring may also submit the application for empanelment.

Note: Masters/Ph.D in either of the Geotechnical Engineering, Tunnel Engineering, Rock Mechanics, Structural Engineering, CS/Instrumentation Engineering would be preferred.

## For retired Government/PSU Engineers (format in Annexure-I)

- (i) Degree in Civil Engineering.
- (ii) The person should have retired from the post of Superintending Engineer (SE) having 10 years or more experience or. equivalent (CGM, ED) and above from MoRTH (CES Roads), CPWD (CES), NHAI, NHIDCL, MES, BRO, PWD, IRCON, Metro Rail Corporation, IA (Corps of Engineer), KRCL etc. Persons due for retirement in next 1 months i.e., till 31st January 2025 can also apply.
- (iii) The person should have experience in execution/planning/monitoring of Tunnel projects in India / abroad.
- (iv) The maximum age for Tunnel Expert is 70 years. The Tunnel Expert shall be empanelled initially for a period of 2 years to a maximum limit of 70 years age.
- (vi) Persons blacklisted by MoRTH, State PWDs, NHAI, NHIDCL or any other Government organization shall be deemed to be disqualified.
- (vii) Person should have worked in MoRTH, State PWD, NHAI, NHIDCL or any Govt. organization on the post of SE or equivalent & above (last salary slip to be provided on submission of application).

(i) Degree in Civil Engineering having 20 years' experience in Design and construction supervision of major tunnel projects (Road/Rail/Metro) of length equal to or more than 4 km.

## Terms of Reference for Empanelment of Tunnel Experts

- 1. The Tunnel expert shall be the part of expert committee or individual basis to be deputed to site to inspect the failed/ completed/on- going tunnels in NHIDCL projects and submit the report in specified timeline. They (Tunnel Experts) will also be assigned the work of study of DPR of these Tunnels and provide their comments in the specified timeline.
- 2. The Expert has to review the DPR prepared by the consultants as per the latest codes/guidelines/specifications. Expert is expected to review all the reports submitted by the consultant and visit the site and furnish their recommendation to be adopted in the DPR to minimise the risk and to ensure fast and safe execution of work. Their recommendation has to be submitted within a fortnight.
- 3. There shall be no conflict of interest of the expert with the Contractor/Concessionaire/AE/ IE/SC etc. associated with the project.
- 4. The above Committee or individual (Tunnel Expert) shall assess entire system in place by the Contractor/Concessionaire/ Consultant for construction/maintenance of Tunnel and its level of implementation, supervision and control.
- 5. The above Committee or individual (Tunnel Expert) shall also verify compliance to specified requirements as published by IRC, MORTH, NHAI, BIS & as per good engineering practices.
- 6. The above Committee or individual (Tunnel Expert) shall carry out technical analysis and find the reasons of failure along with fixing the reasons of failure and submit its preliminary report within 3 days and final report in 7 days to Member concerned.
- 7. All relevant details/ documents shall be clearly mentioned in the report. The suitable remedial measures/ actions to restore the failed structures including restoration of further construction/ O&M activities shall also be recommended.
- 8. The implementation arrangements shall be carried out in either of the following to the Tunnel Expert:
- (i) Field Laboratories established by the Contractor.
- (ii) For Specific tests: testing to be done in District/ Regional/State level laboratories of the employer/NABL accredited labs/ Government engineering Colleges.

NHIDCL shall provide full support in performing task assigned to Tunnel Expert, including support in taking samples, transportation of samples to the laboratory and testing in presence of representative of implementing authority. NHIDCL shall also bear all associate expenses. The Tunnel Expert shall have complete access to the documents pertaining to the project and for this purpose he shall be assisted in his independent evaluation by concerned GM (P) / DGM (P) of NHIDCL.

- 9. The committee shall adhere to the following timelines for completion of the assignment; starting from the date of assignment (T) by NHIDCL.
- a. Site visit, T1=T+1 day
- b. Submission of preliminary Report, T2 =T1+3 days
- c. Submission of Final Report, T3=T2+4 days

- 10. The experts shall not disclose any technical information & data relevant to the project to any third party without prior written permission from the NHIDCL.
