In addition, as per RFP new clause no 38, "Clause 38- Participitation of contractors in bidding process of NHIDCL: The bidder including individual or any of its JV member, who are either having 2(two) on-going EPC project(s) or on going project(s) worth of Rs 500 Cr.(Awarded cost), whichever is more, as on date of bid submission, shall not be eligible to bid for this project and The bidder shall not be awarded more than 2 (two) packages(total cost Rs 500 Cr.) for current bidding process in NHIDCL on EPC basis". There is one bidder namely M/s Bharat Construction who is working in three projects in NHIDCL and AE has certified that two projects namely "Construction of road, bridge and slope protection works of landslide at Bareti(Ex. Km 100.300 to Km 101.060 of NH-34) in the state of Uttarakhand on EPC basis (value of work 30.62 cr)" and "Construction and up gradation including specialized slope treatment of existing road to 2-lane with paved shoulder from km 379.100 to km 380.275
