**Annexure-I**

(a) **M/s Dhariwal Buildtech Ltd - M/s OJSC Euro-Asian Construction Corp “EVRASCON” (JV):** M/s OJSC Euro-Asian Construction Corp “EVRASCON” has not submitted Originals of experience certificate apostille at foreign origin as per clause 2.11.2 (i) of RFP.

(b) **M/s Prasad & Company (Project Works) Pvt Ltd - M/s Twamev Construction and Infrastructure Ltd. (JV) :**

- i. The bidder has only executed superstructures works of 135 mtr & 150 mtr span without executing foundation and substructure, whereas the instant RFP also includes construction of major bridge which includes foundation, substructure and superstructure. Hence, the bidder does not have experience of executing minimum 100 mtr (single span) of construction of bridge as required under clause 2.2.2.2 (ii) of RFP uploaded by Geographical division.

Hence, the bidder M/s Prasad & Company (Project Works) Pvt Ltd - M/s Twamev Construction and Infrastructure Ltd. (JV) is considered technically non-responsive as per clause 2.2.2.2 (ii) of RFP.

(c) **M/s Dhar Construction Company - M/s Royal Infraconstru Ltd (JV):**

- i. Similar Work as per clause 2.2.2.2(ii) : The bidder has not submitted any certificate from project owning authority which establishes that the bidder has executed a similar work as per clause 2.2.2.2(ii) of RFP.
- ii. The bidder M/s Royal Infraconstru Ltd has submitted the bid in which most of the documents which are essential for evaluation of bid are not legible. The bid is evaluated based on legible pages only. Signatures are not clear in many pages of the bid.
- iii. The bidder M/s Royal Infraconstru Ltd has submitted annexure - IV along with CA certificates and Financial Statements for FY 2019-20, FY 2020-21 and FY 2023-24 which are not legible. Additionally, the bidder has submitted documents for calculation of Bid capacity which are also not legible. Therefore, Threshold Technical Capacity, Net Worth and Bid capacity could not be calculated and are considered as zero.
- iv. SA Certificate for Local supplier submitted by the lead member does not have project name. Further, SA Certificate for Local supplier submitted by the other member is not legible.

(d) **M/s ASC Infratech Pvt Ltd - M/s Associated Engineers (JV) :**

- i. M/s Associated Engineers has not submitted its financial statements for the FY 2022-23 and FY 2023-24, because of which Net worth of the Bidder as on 31.03.2024 could not be calculated.
- ii. M/s Associated Engineers has submitted the SA Certificate for Local Content without project name.





**(e) M/s Satish Aggarwal & Co - M/s MM Shawl Engineers and Contractors Ltd (JV) :**

- i. The bidder does not meet the required Threshold technical capacity of Rs. 280.96 as per clause 2.2.2.2 (i).
- ii. The lead member M/s Satish Aggarwal & Co has not attached Annex-II (Technical Capacity of the bidder) and Annex-IV (Details of Eligible Projects). Therefore, the lead member does not fulfil the required criteria for Threshold Technical Capacity i.e. Rs. 168.58 cr as per clause 2.2.2.4 (i).
- iii. The lead member M/s Satish Aggarwal & Co has claimed Average Annual Turnover of Rs. 185.57 crore as per Annexure-III and Appendix-XI submitted in the bid. On examination of the financial statements for preceding 5 years, it was observed that the P&L statements of the company reflect the revenue from sales which have not been considered for calculation of turnover, rendering the Average Annual turnover and bid capacity as zero. The bidder does not meet the required criteria for financial capacity as per clause 2.2.2.3 (ii).
- iv. None of the projects claimed by the other member M/s MM Shawl Engineers and Contractors in its Annexure-IV can be considered as similar work under category 1 or 3 as per clause 2.2.2.2 (ii) of RFP.
- v. M/s Satish Agarwal & Co has submitted the SA Certificate for Local Content without project name. M/s MM Shawl Engineers and Contractors Ltd has not submitted SA certificate for Local Content.
- vi. BG is submitted in favour of GM which should be in favour of MD, NHIDCL.
